#### Note 1:

*"A dog used primarily for the purpose of droving, tending, working or protecting stock, and includes a dog being trained as a working dog."*

#### Note 2:

### 515 Categorisation as farmland

*(1) Land is to be categorised as **farmland** if it is a parcel of rateable land valued as one assessment and its dominant use is for farming (that is, the business or industry of grazing, animal feedlots, dairying, pig-farming, poultry farming, viticulture, orcharding, bee-keeping, horticulture, vegetable growing, the growing of crops of*

*any kind, forestry or aquaculture within the meaning of the [Fisheries Management Act 1994](#), or any combination of those businesses or industries) which—*

*(a) has a significant and substantial commercial purpose or character, and*

*(b) is engaged in for the purpose of profit on a continuous or repetitive basis (whether or not a profit is actually made).*

*(2) Land is not to be categorised as farmland if it is rural residential land.*

*(3) The regulations may prescribe circumstances in which land is or is not to be categorised as farmland.*
