DOG ATTACK STATEMENT GUIDE (WITNESS)

The information below is intended to be used as a guide only. It is designed to assist you in providing us with the necessary details to be used as evidence. This guide should not be regarded as advice or coercion of the facts of the event. It is important that you include all relevant details of the incident.

Compensation. Snowy Monaro Regional Council is not authorised to recoup out of pocket expenses resulting in a dog attack. This is a civil matter between the victim and the offending dog owner.

You must give an honest account of what happened. If you include anything in it that you know to be false or that you do not believe is true, you may be guilty of a crime and liable to imprisonment for 5 years.

- ✓ Please use the statement forms provided by the Ranger
- ✓ Your statement should cover:
 - □ WHEN exactly did the attack take place, including date and time
 - □ WHERE exactly did the attack take place (verge / footpath / road / reserve or park / private address), which direction were you heading, which way did the attacking dog come from
 - □ **WHO** was involved in the attack, providing names and addresses where known or descriptions of people and dogs involved (colour / markings / sex / breed)
 - □ WHAT happened, immediately before, during and after the attack, especially the actions of the attacking dog, its handler / owner and describe any injuries you witnessed occurring.
- ✓ You may wish to include:
 - □ Relevant documents (e.g. vet report), a sketch or photographs.
 - Details of the victim, description name and address if known.
 - □ Was the animal injured or killed in attack on a lead, or effectively contained when attacked?
 - Details of any animal injured or killed in the attack.
 - Name of the alleged attacking dog or their owner if known.
 - Was the attacking dog on a lead?
 - □ Was the attacking dog wearing any type of collar? Can you describe it?
 - □ Was the attacking dog wearing a muzzle?
 - □ What were you doing immediately before the attack?
 - □ What did you do during the attack?
 - □ What was the owner or other person in charge of the attacking dog doing immediately before the attack?
 - □ What did the owner or other person in charge of the attacking dog doing during the attack?
 - □ What was the victim / animal owned or under the control of the victim doing during the attack?
 - □ Were there any other witnesses?
 - □ What did the witness do or say?
 - □ Any other details you believe are important.
