EXECUTIVE SUMMARY

The election of Mayor for the inaugural Snowy Monaro Regional Council is required to be conducted pursuant to Section 225 of the Local Government Act 1993 which states:-

An area must have a mayor who is elected in accordance with this Division.

The Mayor of Snowy Monaro Regional Council is to be elected by the Councillors.

Section 230 of the Local Government Act states:-

(1) A mayor elected by the Councillors holds the office of mayor for 2 years, subject to this Act.

The term of Council is usually for four years, however, Councils whose elections were held in September 2017 have a three year term to September 2020 to align with the Council election cycle.

Advice from the Office of Local Government is that the Mayor will be elected for a two year term followed by a one year term for this three year term of the Council.

Section 230 of the Local Government Act 1993 states:-

- (1) A mayor elected by the Councillors holds the office of mayor for 2 years, subject to this Act.
- (2) A mayor elected by the electors holds the office of mayor for 4 years, subject to this Act.
- (3) The office of mayor:
- (a) commences on the day the person elected to the office is declared to be so elected, and
- (b) becomes vacant when the person's successor is declared to be elected to the office, or on the occurrence of a casual vacancy in the office.
- (4) A person elected to fill a casual vacancy in the office of mayor holds the office for the balance of the predecessor's term.

Section 231 of the Local Government Act 1993 states:

- 1. The Councillors may elect a person from among their number to be the Deputy Mayor.
- 2. The person may be elected for the Mayoral term or a shorter term.

The Deputy Mayor may exercise any function of the Mayor at the request of the Mayor or if the Mayor is prevented by illness, absence or otherwise from exercising the function or if there is a casual vacancy in the Office of Mayor.

Council's Code of Meeting Practice states:

76 Election of Deputy Mayor and Delegate to Committees

The election of Deputy Mayor, shall by resolution, be elected in accordance with section 231 of the Local Government Act 1993.

The following officer's recommendation is submitted for Council's consideration.

COUNCIL RESOLUTION 184/17

That Council

- A. In accordance with Section 255 of the Local Government Act elect a Mayor for the term of two years, ie, from September 2017 to September 2019
- B. In accordance with Section 231 of the Local Government Act elect a Deputy Mayor for the term of two years, ie, from September 2017 to September 2019
- C. Invite nominations for the election of Mayor to September 2019;
- D. Invite nominations for the election of Deputy Mayor to September 2019;
- E. That in the event of there being more than one candidate nominated for either the position of Mayor or Deputy Mayor, an election be held in accordance with Schedule 7 of the Local Government (General) Regulation 2005 and the method of voting be by ordinary ballot.

Note 2: Nominations for Mayor

The Returning Officer (General Manager) called for nominations for Mayor and advised that he had received three (3) nominations from the following Councillors (Clr); Clr Peter Beer, Clr Bob Stewart, Clr John Rooney. Councillors having accepted the nominations, the Returning Officer asked if there were any further nominations. No further nominations were received. The Returning Officer advised the order in which the names will appear on the ballot paper will be determined by a draw out of the barrel and advised the order:-

- 1. Clr Bob Stewart
- 2. Clr Peter Beer
- 3. Clr John Rooney.

At 5.41pm the meeting adjourned to prepare ballot 1 for election of Mayor.

Note 5: Ordinary Ballot One

The Returning Officer advised the meeting that the results of the vote were:- Clr Bob Stewart four (4) votes, Clr Peter Beer two (2) votes and Clr John Rooney five (5) votes. Clr Peter Beer, having the lowest number of votes, was excluded. The Returning Officer advised the order for ballot number 2 for election of Mayor:-

- 1. John Rooney
- 2. Bob Stewart.

Note 6: Adjournment of Meeting

At 5.50pm the meeting adjourned to prepare ballot 2 for election of Mayor.

Note 7: Resumption of Meeting

The meeting resumed at 5.53pm.

Note 8: Declaration of Mayor

The Returning Officer advised the meeting the results of the vote were:- Clr John Rooney seven (7) votes and Clr Bob Stewart four (4) votes, and declared Clr John Rooney elected Mayor for the term September 2017 to September 2019.

Note 9: Chair of Meeting

At the conclusion of the election of Mayor the General Manager congratulated the Mayor on his election and vacated the chair and the Mayor assumed the chair. The Mayor invited the General Manager to continue in the role as Returning Officer to conduct the election of Deputy Mayor.

Note 10: Nominations for Deputy Mayor

The Returning Officer called for nominations for Deputy Mayor and advised that he had received 2 nominations from the following Councillors; Clr Brian Old and Clr Lynley Miners. Councillors having accepted the nominations, the Returning Officer asked if there were any further nominations. No further nominations were received. The Returning Officer advised the order in which the names will appear on the ballot paper will be determined by a draw out of the barrel and advised the order:-

- 1. Clr Lynley Miner,
- 2. Clr Brian Old.

Note 11: Adjournment of Meeting

At 5.59pm the meeting adjourned to prepare the ballot for election of Deputy Mayor.

The meeting resumed at 6.01pm

Note 13: Declaration of Deputy Mayor

The Returning Officer advised the meeting the results of the vote were:- Clr Lynley Miners eight (8) votes and Clr Brian Old three (3) votes, and declared Clr Lynley Miners elected Deputy Mayor for the term September 2017 to September 2019.
