- C. Lobby the Deputy Premier for reallocation of some of the 15 million dollar funds from the Bombala and Delegate Water supply project to the Bombala sewage treatment plant which will enable the project to proceed; and
- D. Provide a supporting letter for the BBR Fund "Deed of Variation" confirming Council's commitment to fund the shortfall in project costs.
