- 2. In accordance with the Guidelines for the Appointment and Oversight of General Managers, issued by the Office of Local Government, authorise the Mayor to:
 - a) Offer the preferred candidate, as determined by Council, the position of Chief Executive Officer of Snowy Monaro Regional Council.
