Expression of Interest Process for Abandoned Vehicles (EOI)

In accordance with Council's Disposal/Sale of Council Items - Procedure.

Evaluation Process

Following the close of the EOI submissions will be checked for completeness and compliance. Submissions that do not contain all information requested (eg completed Application – Offer to Purchase Abandoned Vehicle) may be excluded from evaluation.

CONDITIONS OF RESPONDING:

Lodgement of submissions and Delivery Method

The Submission must be lodged by the Deadline date advertised.

The Submission is to be

Placed in a sealed envelope and clearly endorsed with the EOI Reference Number and Offer to Purchase Abandoned Vehicle and delivered by hand and placed in the Tender Box at 81 Commissioner Street, Cooma or sent through the mail to the General Manager, Snowy Monaro Regional Council, 81 Commissioner Street, Cooma.

Rejection of Submissions

A Submission may be rejected without consideration of its merits in the event that:

It is not submitted before the Deadline date advertised; or

It is not submitted at the place specified in the Expression of Interest; or

It fails to comply with, or qualifies or modifies in any way, any of the requirements of the Expression of Interest.

Submission validity period

All submissions will remain valid and open for acceptance for a minimum period of fourteen days from the Deadline date advertised.

General conditions of Contract

Submissions shall be deemed to have been made on the basis of and to incorporate the General Conditions of Contract for the Supply of Goods.

Applicants to inform themselves

Applicants are deemed to have:

Examined the Expression of Interest and any other information available in writing to Applicants for the purpose of submitting an EOI; Examined all further information relevant to the risks; contingencies, and other circumstances having an effect on their Submission which is obtainable by the making of reasonable enquiries.

Satisfied themselves as to the correctness and sufficiency of their submissions.

Satisfied themselves they have a full set of the Expression of Interest documents and all relevant attachments.

Taken the necessary steps to satisfy themselves to the condition of the vehicle that the EOI relates to and all costs associated with the collection of the vehicle from the impounding yard.

Council does not guarantee the condition or road worthiness of the vehicle being offered for sale. The applicant must at their own expense make arrangements to collect the vehicle at the time convenient to Council following confirmation of Council's acceptance of the successful offer.

Ownership of Submissions
