#### 5. DISCLOSURE OF INTEREST

#### 5.1 MR DUNSHEA

Mr Dunshea declared a significant non-pecuniary interest in Item 6.1- Unreasonable Complainant Conduct restrictions as he has a conflict of interest in this item due to "being named as the first Defendant in the legal action referenced in this motion". Mr Dunshea left the meeting at 6:17pm. Mr Dunshea did not take part in discussion on this item.

#### 5.2 COUNCILLOR HIGGINS

Councillor Higgins declared a non-pecuniary conflict of interest in Item 6.1 – Unreasonable Complainant Conduct as she has a conflict of interest in this item due to "the person referred to in the paper was on her original team in the 2021 Local Government elections".
