## 1. Payment of reservation fees - Historical

In the years prior to amalgamation the method of payment for the reservation of Cemetery Plots differed from Council to Council.

Bombala Shire- if any money was paid for the plot it was considered as being for the "purchase" of the plot and only Burial and Maintenance to be paid at time of use.

Snowy River Shire - if any money was paid for the plot it was considered as being for the "purchase" of the plot and only Burial and Maintenance to be paid at time of use.

There are a few plots which are noted as being deposits and in these cases it is expected that full payment of plot less the deposit will be required at the time of use.

Cooma-Monaro Shire - if any money was paid it was considered as a "reservation" and so has always been considered as a "deposit" for the plot.

Prior to amalgamation in 2016 the deposit amount has been subtracted from the current fee for the plot.

The exception to this was **plots reserved from 15 September 1995 to 1 October 2008** where the wording on the reservation stated that it was the full cost of the plot and so **considered as full purchase of the plot**.

### 2. Changes made 12 May 2016 - Amalgamation

As of May 2016 (amalgamation) all cemeteries were aligned so that the amount paid as "Reservation" was considered as the purchase of the plot.

Fees are reviewed annually and although the plot fee may increase by CPI no additional plot fees are payable on reserved plots. The fee charged for the Burial and Maintenance of the interment may vary to reflect the amounts required to suitably cover the costs of maintaining the upkeep of the cemeteries.
