Purpose of this application form

This application should be completed by a consumer that seeks to acquire a Perpetual Interment Right at a Council managed cemetery. This form is in accordance with requirements of Cemeteries & Crematoria NSW under subsection 56(2) of the Cemeteries and Crematoria Act 2013.

- ONE application is required for EACH Perpetual Interment Right.
- Once the application and payment has been received, you will be issued with an Interment Right. Once received you should keep this document in a safe place. It is recommended you file with your Will and Executor.
- The Perpetual Interment Right does not cover additional costs incurred such as funeral director, headstone, plaque or burial expenses
- Prior to the purchase of any plot that all applicants MUST make themselves aware of Council policy on Plaques and Monuments for the respective cemeteries.
